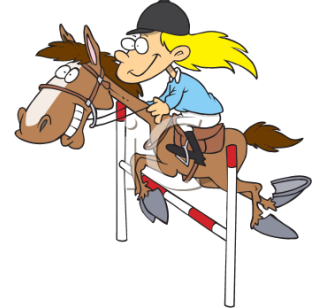

Terms for the Day Camp Enrollment

Age Requirements: Campers must be between the ages of 6 & 16.

Upon Receipt of Registration: Each camper will receive an enrollment confirmation by email or mail. If you have not received your confirmation packet within 10 business days please call the Camp office to confirm receipt of your registration 760-788-1795.

Liability Release Forms: All campers are also required to have a current Liability Release Form on file in the Camp office during their stay. The form will be included with your confirmation packet and included with your registration and payment. **The Liability Release Form must be in our office by start of camp**

Dismissal of Camper: The camp reserves the right to dismiss, in it's sole discretion, any camper whose condition, conduct, influence, or behavior is deemed unsatisfactory or detrimental to the best interest of the Camp or her/his fellow campers or who violates Camp rules and regulations, in which case no refunds will be made.

Extended Care: This is a service that is provided for campers who because of transportation issues need to arrive at camp early and/or stay after camp is over. This service needs to be reserved and paid for in full by start of camp. There are no refunds. Extended Care Hours and Cost per session: 7-9am \$85, 2-6pm \$150,
Please Note: campers not on extended care should be picked up no later than 2:15. Parents will be charged \$1 per minute after 2:15 for campers not picked up. This is a NON-HORSE realated time.

Late Arrival/Early Departure: No reduction in enrollment fees will be made for late arrival of early departure of camper.

Medical: Parent grants permission to utilize medical treatment should the camp staff deem such treatment necessary for the well being of the camper. Said parent will pay all medical expenses involved. Parent understands this camp does not provide medical insurance of any kind for the camper.

Waiting Lists: Registrations are accepted on a first come, first serve basis. When all available spaces are full a wait list will be created.

Please Read: Cancellation Policy: The camp fee includes a \$150 per session non-refundable/non-transferable deposit. For any cancellation received prior to final payment deadline, the camp fee will be refunded minus the non-refundable deposit (\$150 per session). **In order to provide the highest quality horse program we must plan well in advance based on confirmed reservations. For that reason, after the final payment date for your child's camp session no refunds will be issued for cancellations.** Final payments for spring/summer camp sessions will be due on/before June 15th.

Important Additional Information:

It is important for parents and campers to know that we do not allow the following items to be brought to camp. Any of the following items that make their way to camp with your camper will be held safely in the camp office until checkout time.
